

VOLUNTEER RELEASE AND WAIVER OF LIABILITY FORM

This Release and Waiver of Liability (the "release") executed on _____ (date)

by _____ ("Volunteer") releases Reborn Animal Refuge of Colorado, a nonprofit corporation organized and existing under the laws of the State of Colorado and each of its directors, officers, employees, and agents. The Volunteer desires to provide volunteer services for Reborn Animal Refuge of Colorado and engage in activities related to serving as a volunteer. Volunteer understands that the scope of Volunteer's relationship with Reborn Animal Refuge of Colorado is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer; that Reborn Animal Refuge of Colorado will not provide any benefits traditionally associated with employment to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer's services to Reborn Animal Refuge of Colorado.

1. Waiver and Release: I _____ ("Volunteer"), the Volunteer, release and forever discharge and hold harmless Reborn Animal Refuge of Colorado and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to Reborn Animal Refuge of Colorado. I understand and acknowledge that this Release discharges Reborn Animal Refuge of Colorado from any liability or claim that I may have against Reborn Animal Refuge of Colorado with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to Reborn Animal Refuge of Colorado or occurring while I am providing volunteer services.

2. Insurance: Further I understand that Reborn Animal Refuge of Colorado does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of Reborn Animal Refuge of Colorado beyond what may be offered freely by Reborn Animal Refuge of Colorado in the event of injury or medical expenses incurred by me.

3. Medical Treatment: I hereby Release and forever discharge Reborn Animal Refuge of Colorado from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with Reborn Animal Refuge of Colorado.

4. Assumption of Risk: I understand that the services I provide to Reborn Animal Refuge of Colorado may include activities that may be hazardous to me including, but not limited to working with dangerous animals and involving inherently dangerous activities. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and Release Reborn Animal Refuge of Colorado from all liability.

5. Photographic Release: I grant and convey to Reborn Animal Refuge of Colorado all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by Reborn Animal Refuge of Colorado in connection with my providing volunteer services to Reborn Animal Refuge of Colorado.

6. Other: As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Colorado and that this Release shall be governed by and interpreted in accordance with the laws of the State of Colorado. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
